Busy corridor times at the beginning and end of the school day will be avoided. If contact with staff or learners does occur then they will be encouraged to wash hands. Staff should stop a session and return Eddie to his crate in the event of any issues, and report to Sarah Neusinger and follow the school's incident reporting procedures. Eddie will continue with regular training in order to reduce any problem behaviours. Eddie will be fully vaccinated as per veterinary schedule. Dog crate will be kept secure and clean.		Low - 3

Class teachers to make a judgment of suitable learners to dog combination. Preferable learner and Eddie would be 1-1 with adult ratio.	Disposal bags provided for walk.	Low - 5
Panic caused by fear	Individuals who may be afraid of the dog / whole school community	Fear, anxiety	Low - 2	Parents will be consulted and given the opportunity to inform school if their child has a fear of dogs or any allergic reactions before any animal handling sessions are introduced to children. Eddie will only interact with learners when accompanied by a confident handler, as well as having sufficient adults in place to respond to learners and maintain learner safety during these interactions. Eddie's interaction with the school community will be on a voluntary basis and fully supervised by a confident handler.		Low - 1

Staff will be fully informed about how to interact with the dog, especially while any training is ongoing. Learners to be closely supervised during any interaction with the school dog. Eddie will be immediately removed from any potentially difficult situations. Eddie will be immediately removed if any signs of distress or warning signals are observed. Eddie will take part in regular, appropriate training. Eddie will be given time out to allow down time and relaxation. Eddie will wear a harness, lead, and collar at all times when not in the crate.		Low - 2
Animal health	Employee, Learners, third parties or Eddie	Disease, parasites, infections	Low - 6	Eddie must not be able to come into contact with wild rodents etc. due to the possibility of disease transmission. Eddie will attend regular veterinary appointments for appropriate inoculations/vaccinations – owner to maintain record of evidence. Owner/handler of school dog is experienced in the housing, feeding, handling and care requirements. The dog crate is kept secure and clean for the well-being of the animal and the school community. All interactions with Eddie will be fully supervised by a confident handler as well as the classroom teams. Eddie will be closely observed during sessions and any stress signals will be responded to immediately, giving the dog time out to withdraw and rest if necessary. Good diet and enrichment opportunities are available for Eddie daily. Fresh water is available for the Eddie . Eddie is appropriately insured by Sarah Neusinger		Low - 3
